Ryan Swanson Law Update:

Big Changes with Severance Agreements for Employers! The National Labor Relations Board recently issued a decision that

prohibits employers from offering employees severance agreements with nondisclosure and confidentiality provisions that broadly waive employees' rights under the National Labor Relations Act (NLRA). Business owners should review and analyze their severance agreements and other agreements with employees to
